A MESSAGE FROM THE EXECUTIVE DIRECTOR AND BOARD CHAIR

CLASSIC's vision is "a better future where people are supported by fair and equitable laws and systems, which allow them to thrive". There is considerable progress to be made in Saskatchewan to achieve this vision. The current environment presents significant challenges to realizing anything close to genuine social justice.

Demand for CLASSIC's services is high because we are Saskatchewan's only community legal clinic. Current social policies and systems do not adequately address the needs of the community CLASSIC works with and there are very limited front-line services for legal issues in our province.

A key aspect of our vision for a better future is reflected in the second prong of our dual mandate: providing internationally recognized clinical legal education to law and interdisciplinary students. Students who come through our programs are often shocked by how unjust many systems are. As they step into the world and take on leadership roles, we hope they become advocates for change, challenging unjust systems and working towards a fairer future. Unfortunately, we were unable to secure a renewed service contract with the University of Saskatchewan, College of Law beyond this year. We will take at least a one-year hiatus from hosting the Intensive Clinical Law Program to assess future directions and opportunities. Some limited opportunities for students at CLASSIC will still be offered.

This year we reflected on the ongoing, growing access to justice crisis and proposed solutions for it. There is an increasing divide between people who can retain a private lawyer and those who cannot. At the same time, systems are becoming more complex and navigating them is overwhelming. Systems are largely inaccessible to individuals who lack access to a computer and the internet, have limited literacy or technological skills, or struggle with limited English proficiency.

Many 'solutions' for the access to justice crisis do not include front-line, client services or true policy alternatives. It is paradoxical that, on one hand, we are told that law is a noble and challenging profession, while on the other, many proposed solutions to the access to justice crisis involve non-direct service approaches, where self-represented individuals (or unrepresented, depending on preferred terminology) are expected to "manage their own legal matters." Front-line client services, like CLASSIC, represent some of the most effective and impactful solutions to the access to justice crisis. The following comments from CLASSIC's client-survey feedback form demonstrate this:

I would have taken the plea deal without CLASSIC. I am innocent and they ran my trial and we won.

I am truly amazed at all the things they have done for me. Quite stress free. Amazing services. I was so stressed out before I discovered CLASSIC. They eased me of a stressful situation. And did all the work for me. I would not have got it done otherwise. Thank you for everything. If it wasn't for CLASSIC I would be lost.

Thank you so much
CLASSIC. I got quality
legal services.

My lawyer representative went out of her way to deliver my paperwork to the hospital and carehome. She also listened to my concerns.



CLASSIC Service Areas

Walk-In Advocacy Clinic

Full legal representation for clients who experience poverty and injustice and meet the eligibility criteria.

Community Support Program

System navigation primarily in the areas of housing and SIS/SAID (Ministry of Social Services) and crisis/emotional support.



Legal Advice Clinic

Summary Legal advice to self represented or unrepresented individuals from volunteer lawyers in the community.

Student Training and Education Program

The Intensive Clinical Law Program (ICLP), Pro Bono Students Canada (PBSC), and Social Work Practicum (BSW).

CLASSIC'S VALUES

PROFESSIONAL We are committed to the highest standards of competence and ethical practice. This requires us to be good listeners and engage in self reflective practice and evaluation. It also means that we live intension – acknowledging that as a legal clinic we are part of a system that causes suffering and inequity. Our approach to professionalism informs how we educate our students as well as our commitment to take care of ourselves and each other as we work towards a more just community.

TRANSFORMATIVE Everything about how we approach the law challenges the system. We teach, research and engage in social-justice, antiracist and trauma-informed lawyering. By definition, this requires that we acknowledge and challenge the role that we, along with certain laws, policies and legal institutions, have played in reinforcing colonialism and other forms of inequality and oppression.

RESILIENT CLASSIC makes a difference in our clients' lives. The courage and resilience of our clients inspires us – and underscores our commitment to ensuring that CLASSIC's model, and its ability to meet our clients' needs, is viable, even as it grows and evolves.

CLIENT-CENTRED We recognize that our clients, from a diversity of backgrounds and communities, are experts in their own lived experiences. We work with and in community to ensure that our clients' voices are heard, and to approach the challenges faced by our clients holistically, and in context. We are committed to learning from our clients and stakeholders, through reciprocity and respect.

WALK-IN ADVOCACY CLINIC

CLASSIC's Walk-in Advocacy Clinic (WAC) provides full legal representation in approximately 20 areas of law to people who experience poverty and injustice. This program works in tandem with the Intensive Clinical Law Program with students working on assigned client files under the direct supervision of staff lawyers. Of the 1083 client files CLASSIC assisted with in 2024 - 2025, 904 files were in our top 5 areas of law.



Remaining areas of Law

577 applications were made to CLASSIC requesting full legal representation.
156 were denied primarily due to capacity and 38 were withdrawn primarily due to loss of contact.



- CLASSIC opened 418 new files
- CLASSIC carried over 318 files
- CLASSIC closed 346 files

CLASSIC continues to see an upward trend of judicial reviews and appeals generated through our work. In 2024-2025, CLASSIC did over **170** appeals and judicial reviews including at the Supreme Court of Canada level.




WHO DID CLASSIC PROVIDE FULL LEGAL REPRESENTATION TO?

CLASSIC works with a diverse community of individuals and families. Age and gender of individuals served





LEGAL ADVICE CLINIC (LAC)

CLASSIC's Legal Advice Clinic (LAC) works in partnership with Pro Bono Law Saskatchewan (PBLS) to provide unrepresented or self-represented individuals with free summary legal advice from practicing lawyers in the areas of criminal, family, immigration and civil law.

This clinic is for people:

- who experience poverty,
- do not qualify for full representation legal services through CLASSIC's Walk-in Advocacy Clinic,
- do not qualify for Legal Aid services, and
- cannot afford to retain a private lawyer.



This year, CLASSIC partnered with Pro Bono Law
Saskatchewan (PBLS) to host free legal advice clinics out of
CLASSIC. This pilot project was implemented in July 2024
with CLASSIC hosting a total of 6 clinics, assisting 15
community members.

*With the housing crisis and houselessness continuing to rise in Saskatoon, CLASSIC partnered with a volunteer lawyer, to offer legal advice sessions to community members who did not meet our eligibility criteria for Residential Tenancies matters. This is an initiative that CLASSIC will pilot for the next year. This initiative started on February 26 and completed 9 ORT LACs in 2024-2025.

COMMUNITY SUPPORT PROGRAM (CSP)

CLASSIC understands our clients' legal issues are not always the central challenges they face. CLASSIC's Community Support Worker (CSW) assists community members with their nonlegal needs primarily through systems navigation. Having a holistic and inter-disciplinary team makes us more client-centred, effective and meets more of the needs for the community members.

Community Support clients



This year the CSW worked with 120 community members, 73 remained active and carried into the next year.

Systems navigation is the largest area of work. The CSW assisted community members:

- navigate Saskatchewan
 Income Support
 (SIS)/Saskatchewan Assured
 Income for Disability (SAID),
- with housing system navigation including locating, viewing and filling out rental applications, and
- through community street outreach.

The CSW started attending Station 20 West one morning a week in 2025, to reduce barriers for people to access help with housing and income assistance system navigation. The CSW has connected with 36 people through this initiative.

In March, during the biggest overdose crisis in Saskatoon's history, the CSW started checking in with people who appeared to be houseless around CLASSIC. On these walk-abouts, the CSW checked in with over 100 people while handing out snacks, water, and Narcan kits. She also talks with people to see if they are in need of any assistance and so they know they are cared about.



SPECIAL PROJECTS & COMMUNITY CONNECTIONS


Special Project-Project ID

Having identification is a basic starter for many aspects of life.
Through community consultations, CLASSIC identified the need for many community members to obtain ID and "Project ID" was born. Through our clinics in 2024–2025, 187 birth certificate applications and 45 health card applications were submitted for individuals to obtain their ID.
